

Guidelines for Subsidies for Participation in International Invention Exhibitions for Faculty and Staff at Chung Yuan Christian University

- Article 1. In order to encourage faculty and staff at our University to participate in renowned international invention exhibitions, enhance the international visibility of our University, promote technology transfers, and facilitate technological advancements, these guidelines for subsidies and awards (hereinafter referred to as "the guidelines") are hereby established.
- Article 2. The term "renowned international invention exhibition" in these guidelines refers to exhibitions with participation from at least fifteen countries or regions and featuring more than three hundred exhibits.
- Article 3. Faculty and staff members with full-time positions at our University, whose patents have obtained national or international patent application numbers, and where Chung Yuan Christian University is listed as one of the patent holders, are eligible to apply for subsidies for exhibition participation and award incentives according to these guidelines.
- Article 4. Subsidies for Exhibition Participation
1. Expenditures related to exhibition participation may be subsidized based on the decisions of the Patent and Technology Transfer Benefits Committee for the international invention exhibitions approved for that year. Subsidized items include basic registration fees, overseas travel expenses, or other necessary exhibition-related expenses.
 2. Each faculty or staff member is eligible for a subsidy once per year. After the initial screening by the Executive Operation Office for Industry-Academia Cooperation, if the number of applications exceeds the budgeted quota, the applications will be forwarded to the review panel of the Patent and Technology Transfer Benefits Committee for consideration. The review process should take into account the importance of participating in the exhibition as well as the research potential, originality, and contribution of the applicants.
 3. The subsidy amount is determined based on the annual budget or other project funding allocations.
- Article 5. Application for Award Incentives
1. Within one month after the conclusion of the exhibition, participants who have attended international invention exhibitions specified for subsidies by the Ministry of Economic Affairs Intellectual Property Office or approved by the Patent and Technology Transfer Benefits Committee may submit the following relevant documents to the Executive Operation Office for Industry-Academia Cooperation for the application of award incentives:
 - (1) Application Form
 - (2) Detailed agenda or itinerary of the conference
 - (3) Copy of the patent certificate or proof of patent application for the exhibited invention.
 - (4) Proof of award.
 2. The maximum award amounts for a single patent are as follows:

- (1) Superior Gold Award: NT\$40,000 per case.
 - (2) Gold Award: NT\$30,000 per case.
 - (3) Silver Award: NT\$20,000 per case.
 - (4) Bronze Award: NT\$10,000 per case.
3. For multiple-country patent applications under the same invention, they are considered as a single case.

Article 6. The Directions are passed by the School Administration Council, and shall be promulgated and enforced by the President. The same shall apply where the Directions are amended.
